## Youth: Requires Additional Assistance





## Program Year 2020 (Issued July 2020)

Under WIOA, North Carolina has defined (DWS Policy Statement 10-2018) the eligibility category of In-School and Out-of-School youth who requires additional assistance to complete an educational program or to secure or hold employment as:

- 1. In-School Youth, ages 14-21, low-income, and
  - a) Has poor attendance patterns in an educational program during the last 12 calendar months; **or**
  - b) Has been expelled from school within the last 12 calendar months; or
  - c) Has been suspended from school within the last 12 calendar months; or
  - d) Has below average grades of less than a "C" grade point average; or
  - e) Has previously been placed in out-of-home care (foster care, group home, or kinship care) for more than 6 months between the ages of 14-21; **or**
  - f) Has a currently incarcerated parent(s)/guardian.

NOTE: In each local area, not more than 5% of the newly enrolled In-School Youth assisted in a given program year may be made eligible based upon WIOA Section 129(a)(3)(B) as an individual who requires additional assistance to complete an educational program or to secure or hold employment. [Section 129(a)(1)(C)(iv)(VII)]

- Out-of-School Youth, ages 16-24, <u>low-income</u> and
  - a) Has dropped out of a post-secondary educational program during the past 12 calendar months; **or**
  - b) Has a poor work history, to include no work history, or has been fired from a job in the last 6 calendar months; **or**
  - c) Has previously been placed in out-of-home care (foster care, group home, or kinship care) for more than 6 months between the ages of 16-21; **or**
  - d) Currently has an incarcerated parent(s)/guardian.

All youth enrolled under this eligibility criteria are required to be low-income.

Staff should use the following selfattestation form along with any other form of back-up documentation available to support the identified eligibility category and document in case notes.
